Subject: Export of the ex-ship São Paulo: Reiteration of communication.

Reference: If you respond to this Letter, expressly indicate Process No. 02001.012028/2021-48.

Dear sir,

- 1. We refer to SEI document No. 13348250 in response to Official Letter No. 220/2022/DIQUA (13314372), in which Oceans Prime confirms receipt of the notification that the Competent Authority of the importing country has requested the preparation of a new inventory of hazardous materials, to be submitted in accordance with the EU Ship Recycling Regulation (EU Ship Recycling Regulation), and which must be carried out by another company authorized for this purpose. Additionally, Oceans Prime requests that IBAMA ratify with the Turkish Authority " that the 'inventory of hazardous materials' was analyzed and approved by IBAMA for being complete and having complied with the legal requirements for its issuance".
- 2. We would like to clarify that, without prejudice to communications between the competent authorities of the exporting and importing countries, and in accordance with the rules of the Basel Convention, the authority of the importing country may request additional documentation from the exporting company, at any time. With this, we reiterate that the consent of the Turkish Authority was issued with conditions (as already informed in Official Letter No. 151/2022/DIQUA) and that Oceans Prime Offshore Agenciamento Marítimo Ltda. should be aware that that Authority may require the new hazardous waste inventory upon arrival of the ex-ship at the port of destination, and that this inventory must be carried out "at the expense" of SÖK DENİZCİLİK TİC. VE LTD ŞTİ.
- 3. Finally, informed that the Turkish authority has already been informed that the former ship SAO PAULO has been in international waters since August 4th, as well as that Ibama has notified Oceans Prime about the additional inventory requirement.
- 4. We remain at your disposal for any additional clarifications that may be necessary.


