## **Example of Warning Letters Sent**

## Dear Basel Competent Authority/Focal Point for India:

-- Please acknowledge receipt of this letter--

Following up on our earlier letters to you of April 26, and May 10, the Basel Action Network and Toxics Link writes to UPDATE again you on more impending <u>likely illegal shipments</u> of plastic <u>waste</u> currently on their way from the US to India.

We hope you had time to act on the earlier notice and now we are alerting you to more similar shipments. As noted in the table below, the containers indicated below will arrive in India on the indicated vessels, to the indicated ports on the indicated dates. We hope that these shipments will be met by somebody from the Environment Ministry and Customs Agency to ensure they are examined to see if they are legal shipments. We have also attached more detailed information in a excel file to this letter.

As you may be well aware, as the US is a non-Party, exports of Basel controlled wastes from the US can only be allowed into India if they are not a Basel Controlled waste under Annex VIII or Annex II of the Basel Convention.

The new Plastic Waste amendments adopted at COP14 in <u>Decision 14/12</u> categorize plastic waste into three categories. First, there are the plastic wastes deemed to be non-hazardous (B3011, Annex IX) and thus outside of the control of the Convention. Second, there are the plastic wastes deemed to be hazardous (A3210, Annex VIII) (e.g. brominated flame retardant plastic) and finally and <u>most importantly</u> there are the new plastic wastes for special consideration (Y48 of Annex II).

We are sending you this alert as we believe there is a <u>high probability</u> that the wastes indicated in these inbound shipments are examples of Y48 wastes and thus contraband due to them <u>failing</u> to:

- a) meet the contamination levels stipulated by India following the Basel Amendments, (as required to avoid Y48 designation), or
- b) be unmixed and sorted single polymer shipments (with the sole exception of being a mixture of PE, PET and PP polymers), (as required to avoid Y48 designation), or
- c) be free from being a halogenated polymer such as PVC, (required to avoid Y48 designation), or
  - d) be destined to an environmentally sound facility (required of all shipments of waste), or
- e) be managed under the Convention's Annex IV R3 designation (required to avoid Y48 designation), or
- f) contain what they are purported to contain as listed in the Bill of Lading (as required of all shipments).

<u>These shipments require your effort to make the final determination</u> as to whether the shipments are Y48 (illegal to import from the US) or B3011 (legal to import from the US). To do this the containers will have to be opened at the port for inspection. As you are no doubt aware, the determination of the above cannot be made by visual inspection alone.

- First, the inspector will need to read the bill of lading and determine whether the shipment indeed contains what it says it contains.
- Second, it is important to photograph the examination for future reference.
- Third, one will need to determine if the plastic wastes are mixed or are all in fact one polymer, or
  if mixed are only a mix of PP, PE and PET.
- Fourth, one will need to determine the levels of contamination in the shipment and whether these levels meet the criteria for contamination imposed by the policies and rules of India.

- Fifth, one will need to determine whether the shipments contain halogenated polymers. This can be done by using an XRF gun if your department has one. If not, examine the bill of lading and see if it mentions PVC or not.
- Sixth, one will need to examine the whole container and not just the bales near the door. Very
  commonly, contraband is packed in the closed side of the containers while containers at the door
  are clean and sorted.
- Finally, one might also need to determine if the destination will recycle all of the material and will do so in a permitted, environmentally sound facility.

It is very important that the new Basel Plastic Waste Amendments function as intended by the Parties to the Basel Convention. We thank you for your careful attention to this matter of vital importance to ensure that they do function and that the environment of India and the world is thus better protected.

Thank you for your kind attention. We would appreciate a short note from you as to your findings regarding these shipments. If you find that these shipments are in fact illegal in any respect, we stand ready to assist you in having the containers repatriated to the United States. Please contact us should you have any questions. We will be reporting on the fate of these shipments at the upcoming 15th Conference of the Parties to the Basel Convention in Geneva in June. We thank you for your cooperation and consideration of this alert.
